ARTICLE 1 - PREAMBLE

2	This Agreement is entered into this 30 the day of 0 and between
3	the City of Lauderhill, Florida, (the "City") and the Florida State Lodge, Fraternal Order of
4	Police, (the "FOP" or the "Union.")
5	WHEREAS, this Agreement reduces to writing the understandings of the City and
6	the FOP to comply with the requirements contained in Chapter 447, Florida Statutes, as
7	amended; and
8	WHEREAS, this Agreement is entered into to promote a harmonious relationship
9	between the City and the FOP and to encourage more effective employee service in the
10	public interest; and
11	WHEREAS, it is understood that the City is engaged in furnishing essential public
12	services which vitally affect the health, safety, comfort and general well-being of the public
13	and the FOP recognizes the need to provide continuous and reliable service to the public;
14	NOW THEREFORE, in consideration of the mutual covenants and agreements
15	herein contained, the parties agree as follows.
16	

ARTICLE 2 - RECOGNITION

2	The City recognize	s the Florida State Lodge, Fraternal Order of Police, Inc. as the exclusive
3	bargaining agent fo	or the purpose of collective bargaining with respect to wages, hours and
4	other conditions of	employment for those employees included within the certified bargaining
5	unit, and any other	inclusions or exclusions mutually agreed to, in writing, by the parties, and
6	approved by the P	ublic Employees Relations Commission. The bargaining unit is defined
7	by Florida Public E	mployees Relation Commission Certification Number 1171, which states
8	as follows:	
9	Included:	All full time sworn employees of the City in the classification of police
10		officer and sergeant.
11	Excluded:	All other employees of the City.

ARTICLE 3 - TERM OF AGREEMENT

- 3.1 This Agreement shall be effective upon ratification by the FOP and the City,
 and shall continue until September 30, 2020.
- 4 3.2 Negotiations for a successor collective bargaining Agreement shall
 5 commence on or before August 1, 2020.
- 3.3 In the event a new collective bargaining Agreement is not reached prior to
 the expiration of this Agreement, the terms and conditions of this Agreement
 shall be binding upon the parties until the ratification of a new collective
 bargaining Agreement, except as set forth in Section 30.6 of this
 Agreement.
- 11 3.4 It is understood and agreed that this Agreement constitutes the total 12 agreement between the parties. The term of this Agreement shall not be 13 amended, except by the mutual written consent of the parties as they may 14 from time to time agree.
- 153.5This Agreement shall not be construed to deprive an employee of any benefit16or protection granted by the laws of the State of Florida or ordinance of the17City of Lauderhill.

ARTICLE 4 - REPRESENTATION OF THE UNION

2	4.1	The President of the FOP and/or the person or persons designated by said
3		President, shall have full authority to conclude an Agreement on behalf of
4		the Union, subject to a ratification vote of members of the Bargaining Unit.
5	4.2	It is understood that the Union President and/or his or her designee is the
6		official representative of the Union for the purpose of negotiating with the
7		City.
8	4.3	Negotiations entered into with persons other than those as defined herein,
9		regardless of their position or association with the Union, shall be deemed
10		unauthorized and shall have no weight or authority in committing or in any
11		way obligating the Union.

ARTICLE 5 - REPRESENTATION OF THE CITY

- 5.1 The City shall be represented by the City Manager, or a person or persons
 designated in writing to the Union by the City Manager. The City Manager or
 his or her designated representative(s) shall have full authority to conclude an
 Agreement on behalf of the City, subject to ratification by an official resolution
 of the City Commission.
 5.2 It is understood that the designated representative(s) of the City are the official
- 8 representatives for the purpose of negotiating with the Union.
- 9 5.3 Any negotiations entered into with persons other that those defined herein, 10 regardless of their position or association with the City, shall be deemed 11 unauthorized and shall have no weight or authority in committing or in any 12 way obligating the City.

1 ARTICLE 6 - FOP ACTIVITIES AND BULLETIN BOARDS

2	6.1	The FOP agrees that there shall be no solicitation for membership in the FOP,
3		signing up of members, collecting of any fees, dues or assessments or
4		meetings of the employee organization on City time.
5	6.2	With prior approval of the Chief or designee, on a case-by-case basis, the
6		FOP may distribute literature and hold Union meetings on City time.
7	6.3	The FOP shall have a bulletin board in the police department in order to post
8		information regarding union business. All postings shall be approved by the
9		Police Chief in advance of being posted.

ARTICLE 7 - NO STRIKE

2 7.1 "Strike" means the concerted failure to report for duty, the concerted absence 3 of employees from their positions, the concerted stoppage of work, the concerted submission of resignations, the concerted abstinence in whole or 4 5 in part by any group of employees from the full and faithful performance of their duties of employment with the City, participation in a deliberate and 6 7 concerted course of conduct which adversely affects the services of the City. picketing or demonstrating in furtherance of a work stoppage, either during 8 9 the term of or after the expiration of a collective bargaining agreement.

7.2 Neither the FOP, nor any of its officers, agents and members, nor any
employee organization members, covered by this Agreement, will instigate,
promote, sponsor, engage in, or condone any strike, sympathy strike,
slowdown, sick-out, concerted stoppage or work, illegal picketing, or any other
interruption of the operations of the City.

7.3 Each employee who holds a position with the FOP occupies a position of 15 16 special trust and responsibility in maintaining and bringing about compliance with this Article and the strike prohibition in Section 447.505, Florida Statutes 17 18 and the Constitution of the State of Florida, Article 1, Section 6. Accordingly, the FOP, its officers, stewards and other representatives agree that it is their 19 20 continuing obligation and responsibility to maintain compliance with this Article 21 and the law, including their responsibility to abide by the provisions of this Article and the law by remaining at work during any interruption which may be 22 23 initiated by others; and their responsibility, in event of breach of this Article or

- the law by other employees and upon the request of the City, to encouragé
 and direct employees violating this Article or the law to return to work, and to
 disavow the strike publicly.
- 4 7.4 Any or all employees who violate any provisions of the law prohibiting strikes
 5 or of this Article may be dismissed or otherwise disciplined by the City.
- 7.5 The City agrees to adhere to the provisions of Chapter 447, Florida Statutes,
 regarding the prohibition on lockouts.

ARTICLE 8 - DUES CHECK-OFF

- Any member of the FOP who has submitted a properly executed dues 8.1 2 deduction form (Appendix A) to the City Manager or his or her designee may 3 4 have his or her membership dues in the FOP deducted from his or her wages. Dues deducted from wages of a member will be transmitted to the FOP on a 5 monthly basis. However, the City shall have no responsibility or any liability 6 7 for the improper deduction of dues. 8 8.2 The FOP shall indemnify, defend and hold the City harmless against any and all claims, suits, orders, and judgments brought and issued against the City 9
- as a result of any action taken or not taken by the City under the provisions of
 this Article.

ARTICLE 9 - POLITICAL ACTIVITY

- 9.1 There shall be no discrimination against any employee covered by this
 3 Agreement by reason of political affiliation.
- 9.2 No employee covered by this Agreement shall, directly or indirectly, solicit or
 take part in soliciting an assessment, subscription or contribution of any
 employee of the City for any political organization or purpose during work
 hours or on City property.

ARTICLE 10 - MANAGEMENT RIGHTS

- 10.1 The City has and will continue to retain the unilateral right to operate and
 manage its affairs in all respects; and the powers or authority which the City
 has not abridged, delegated or modified by the express provisions of this
 Agreement are retained by the City. The rights of the City, through its
 management officials, shall include, but shall not be limited to, the right:
- 7 10.1.1 To manage and direct all employees of the City and the Police Department
 8 and determine the standards and qualifications therefore;
- 9 10.1.2 To hire, lay off, rehire, promote, transfer, schedule, assign and retain 10 employees in positions with the City;
- 11 10.1.3 To suspend, demote, discharge or take other disciplinary action against 12 employees for just cause;
- 1310.1.4To demote police lieutenants into the rank of sergeant, provided that the14lieutenant has previously served as a sergeant for the City and provided that15the demotion does not become effective until the lieutenant exhausts any16rights he/she has under any applicable collective bargaining agreement to17appeal said demotion.
- 1810.1.5To maintain the efficiency of the operations of the City and the Police19Department;
- 10.1.6 To determine the structure and organization of City government, including the
 right to supervise, subcontract, expand, consolidate or merge any department
 and to alter, combine, or reduce any division thereof;

- 110.1.7To determine the number of all employees who shall be employed by the City,2the job make up, activities, assignments and the number of hours and shifts3to be worked per week including starting and quitting time of all employees4subject to the Article entitled Hours of Work and Overtime;
- 5 10.1.8 To determine the number, types, and grades of positions or employees 6 assigned to an organizational unit, department or project, and the right to alter, 7 combine, reduce, expand, or cease any position:
- 8 10.1.9 To determine internal security practices;
- 9 10.1.10 To control the use of equipment and property of the City;
- 10 10.1.11 To fill any job on an emergency basis;
- 11 10.1.12 To formulate and implement department policy, rules and regulations; and
- 12 10.1.13 To introduce new or improved services, maintenance procedures, materials, 13 facilities and equipment, and to have complete authority to exercise those 14 rights and powers incidental thereto, including the right to make unilateral 15 changes when necessary.
- 1610.2If the City fails to exercise any one or more of the above functions from time17to time, it shall not be deemed a waiver of the City's right to exercise any or18all of such functions.
- 1910.3Any management rights, powers or privileges of the City not expressly20modified or restricted by a specific provision of this Agreement shall remain21with the City and shall not be subject to the grievance or arbitration procedure22contained herein. This provision shall not affect the Union's right to grieve

and/or arbitrate the application of any of the above-mentioned management
 rights.

1 ARTICLE 11 - GRIEVANCE AND ARBITRATION PROCEDURE

- 11.1 In a mutual effort to provide harmonious working relations between the parties
 to this Agreement, it is agreed to and understood by both parties that there
 shall be a procedure for the resolution of grievances between the parties
 arising from any alleged violation of the specific terms of this Agreement.
- 7 11.2 A grievance not advanced to the higher step within the time limits provided
 8 shall be deemed permanently withdrawn as having been settled on the basis
 9 of the decision most recently given. Failure on the part of the City to answer
 10 within the time limits set forth in any step will entitle the employee to proceed
 11 to the next step.
- 12 11.3 Grievances shall be processed in the following manner.
- 13 STEP 1: Any aggrieved employee, with or without a 14 FOP representative, shall file a written grievance on the form attached as Appendix B with the employee's immediate supervisor within ten 15 (10) calendar days of the occurrence or knowledge of the matter giving 16 17 rise to the grievance. Such grievance shall be presented in writing, 18 shall be signed by the employee and shall specify: (a) the date of the 19 alleged grievance; (b) the specific article or articles and section or sections of this Agreement allegedly violated; (c) the facts pertaining to 20 21 or giving rise to the alleged grievance; and (d) the relief requested. The 22 employee's immediate supervisor may informally meet with the 23 grievant to address the grievance. A Union representative may be 24 present at the meeting upon the grievant's request. The immediate

nn

supervisor shall reach a decision and communicate in writing to the aggrieved employee within ten (10) calendar days of receipt of the grievance.

STEP 2: If the grievance is not resolved at Step 1, or if 4 no written disposition is made within the Step 1 time limits, he/she shall 5 6 have the right to appeal the Step 1 decision to the Chief of Police or his/or her designee within ten (10) calendar days of the due date of the 7 Step 1 response. Such appeal must be accompanied by a copy of the 8 9 original written grievance, together with a signed request from the employee/Union requesting that the Step 1 decision be reversed or 10 modified. The Chief of Police or his/her designee may conduct a 11 meeting with the grievant and his/her representative, if needed. The 12 Chief of Police or his/or her designee shall, within ten (10) calendar 13 14 days after the presentation of the grievance (or such longer period of time as is mutually agreed upon in writing), render his/her decision on 15 the grievance in writing. 16

17STEP 3:If the grievance is not resolved at Step 2, or if18no written disposition is made within the Step 2 time limits, he/she shall19have the right to appeal the Step 2 decision to the City Manager or his20or her designee within ten (10) calendar days of the due date of the21issuance of the Step 2 decision. Such appeal must be accompanied22by the filing of a copy of the original written grievance, together with a23request form signed by the employee/Union requesting that the Step

2 decision be reversed or modified. The City Manager or his/her 1 designee may conduct a meeting with the grievant and his/her 2 representative, if needed. The City Manager or his/her designee shall, 3 within ten (10) calendar days (or such longer period of time as is 4 mutually agreed upon in writing), render his/her decision in writing. For 5 6 grievances challenging the issuance of a written reprimand, the City Manager's decision at Step 3 shall be final and binding and neither the 7 aggrieved employee nor the FOP shall have the right to advance said 8 grievance to arbitration, provided such written reprimand is the first 9 written reprimand issued to that particular employee in the two-year 10 period preceding the issuance of the reprimand. If an employee is 11 issued more than one written reprimand within a two-year period, that 12 employee or the FOP shall have the right to grieve the written 13 14 reprimand(s) beyond the first one to arbitration.

15 11.4 Where a grievance is general in nature, in that it applies to a number of 16 employees having the same issue to be decided, it shall be presented 17 directly to the Chief of Police or his/her designee at Step 2 of the grievance 18 procedure, within the time limit provided for the submission of the grievance 19 in Step 1, and signed by the aggrieved employees or the FOP 20 representative on their behalf.

11.5 In the event a grievance processed through the grievance procedure other
 than a grievance challenging the issuance of a first written reprimand of an
 employee in a two year period has not been resolved at Step 3, the City or the

FOP may submit the grievance to arbitration within ten (10) calendar days after the City Manager (or a designee) renders a written decision on the grievance, or the due date of that decision if no written decision is made.

5 accordance with Section 11.5 above provided that such member receives
6 written consent from the FOP within ten (10) calendar days after the City
7 Manager (or a designee) renders a written decision on the grievance, or the
8 due date of that decision if no written decision is made, and provides the City
9 with a copy of such written consent within that ten (10) day period.

The arbitrator may be any impartial person mutually agreed upon by the 11.7 10 parties. In the event the parties are unable to agree upon said impartial 11 arbitrator within ten (10) calendar days after the City or FOP request 12 arbitration, the party demanding arbitration shall, within ten (10) calendar days 13 14 of the date on which the parties reach impasse over the mutual selection of an arbitrator as set forth above, request a list of seven (7) names from the 15 Federal Mediation and Conciliation Service. Within ten (10) calendar days of 16 receipt of the list, the parties shall alternatively strike names, the City striking 17 first. The remaining name shall act as the Arbitrator. 18

1911.8The City and the FOP shall mutually agree in writing as to the statement of20the grievance to be arbitrated prior to the arbitration hearing, and the21Arbitrator shall confine his/her decision to the particular grievance specified.22In the event the parties fail to agree on the statement of the grievance to be23submitted to the Arbitrator, the Arbitrator will confine his/her consideration

The Arbitrator shall have no authority to consider or 7 rule upon any matter, which is stated in this Agreement not to be subject to arbitration. 8

The impartial19Arbitrator's fee and any related expenses including any cost involved in20requesting a panel of arbitrators shall be paid by the non-prevailing party.21The hearing room shall be supplied and designated by the City. Any person22desiring a transcript of the hearing shall bear the cost of such transcript,23unless both parties mutually agree to share such cost.

For the purpose of this Article, an 21 insubstantial amount of time shall be considered any period of time less 22 than one-quarter (1/4) hour.

23.1 2 When an employee covered by this Agreement is compelled to be absent from duty because of an injury or illness determined to be compensable under 3 the provisions of the Worker's Compensation Act, he/she shall be entitled to 4 full pay less any benefit under the Worker's Compensation Act for a period of 5 time not to exceed forty-five (45) working days. The same time period may 6 be extended based upon a review and recommendation by the Human 7 Resources Director and the Police Chief with the approval of the City 8 Manager, based upon the results of a medical examination. To be eligible 9 10 for any extensions, the employee must, if directed by the City Manager, submit an application for disability retirement to the Pension Board or submit to a 11 physical examination to determine the approximate length of time necessary 12 to return to duty. The City Manager may, in his or her sole discretion, at any 13 14 time during the extension, terminate such extension if he/she determines that the extension is no longer in the best interest of the City and the employee 15 concerned. In that event, the employee, at the sole and exclusive discretion 16 of the City Manager, may either be placed on unpaid leave status (after the 17 employee is allowed to exhaust all accrued leave) or separated from 18 employment. 19

20 23.2 When so directed by the City, any employee out of work due to an on-the-job 21 injury shall present himself/herself for a medical examination. The City will 22 bear the full expense of said examination by a City appointed physician. The 23 failure of such employee to present himself/herself for an examination as

- 1524.4The following procedures shall apply to the drug and alcohol tests16administered to employees:
- 17(A) The City may request urine samples for the presence of drugs18and a breathalyzer test for the presence of alcohol. A urine sample19shall be split and one part of the split sample shall be screened20instantly; the other sample will be sent to a laboratory and tested only21if the instant test results are positive. If the instant sample tested22positive, the employee will be placed on administrative leave without23pay pending the results of the confirmatory test. If the confirmatory

test reveals a negative result, the employee will be provided with 1 back pay retroactive to the date he/she was placed on leave without 2 3 pay. A breathalyzer test result of over .02 for the presence of alcohol will necessitate a second test being conducted fifteen (15) minutes 4 later. If the result is between .02 and .04 blood alcohol level on the 5 second test, the employee will be sent home for the day without pay 6 7 (or may use sick or vacation leave), but will not be disciplined. If the result of the second test is above .04 for blood alcohol, the employee 8 will be placed on administrative leave without pay pending a final 9 disciplinary action from the City. 10

11 **(B)** The test shall be performed by a reputable testing company at the City's Police Department or at a reputable hospital or 12 laboratory certified by the State of Florida as a medical laboratory, 13 14 which complies with the scientific and technical guidelines for federal drug testing programs and the standards for certification of 15 laboratories engaged in urine drug testing for federal agencies 16 issued by the Alcohol, Drug Abuse and Mental Health Administration 17 of the U.S. Department of Health and Human Services and comply 18 with applicable Florida Statutes. 19

(C) Urine specimens shall be drawn or collected at the City's
 Police Department or a laboratory, hospital, doctor's office or medical
 facility. A union representative shall be allowed to accompany the
 employee, if requested, to the test and observe the collection of the

All specimen containers and vials4shall be sealed with evidence tape and labeled in the presence of the5employee and the union representative, if available.

6 (D) After considering the results of the test(s), the City may take 7 such disciplinary action as is appropriate pursuant to this agreement. 8 Such disciplinary action may include referral to a substance abuse 9 program or Employee Assistance Program for Assessment, 10 counseling and referral for treatment and rehabilitation as 11 appropriate.

(E) The results of urine tests performed hereunder will be held
 confidential to the extent permitted by law. Tests shall be performed
 for the presence of alcohol, non-prescribed controlled substances,
 chemical adulteration and/or narcotic drugs.

 17 recognized testing standards. The following standards shall be used
 18 to determine what level of detected substances shall be considered

- **RE:** Proposed Resolution Providing For Ratification of the Collective Bargaining Agreement Between the City and the Florida State Lodge, Fraternal Order of Police

RECOMMENDATION

It is recommended that the City Commission adopt the enclosed resolution, which authorizes and approves the ratification of the Collective Bargaining Agreement (the "Agreement") between the City of Lauderhill (the "City") and the Florida State Lodge, Fraternal Order of Police.

AGREEMENT HIGHLIGHTS AND SUMMARY

The Agreement, which applies to the City's police officers and police sergeants, and only benefits employees employed on the date of ratification, is for a one (1) year term commencing October 1, 2019 and expiring September 30, 2020. The following key sections of the Agreement have been summarized for the Commission's convenience:

- <u>Wages</u>.
 - (a) <u>Step Pay Plans.</u> The parties agreed to amend the step pay plan for officers and sergeants. For officers, each step in the pay plan will be increased by approximately four percent (4%), as compared to salaries paid in fiscal year 2019. For sergeants, their increases were set in accordance with a recent pay study to ensure that they were paid within the top third in terms of salaries within Broward County.
 - (b) <u>On-call.</u> Employees designated as being "on-call" or on "rotational on-call" during a pay period will receive \$100 and \$50 per pay period, respectively.
 - (c) <u>Night differential</u>. Employees assigned to midnight shift for a pay period shall receive a \$75 incentive each pay period.
 - (d) <u>Premium Pay</u>. Employees in certain special assignments will receive a weekly allowance \$30 per week, which is an increase from \$20 per week.
 - (e) <u>Longevity Pay</u>. Employees with at least 10 years of service will receive a lump sum payment equal to 1% of their base salary.
- **Drug testing**. The parties have agreed to update the drug testing article in accordance with applicable standards for public safety departments.

• Fringe Benefits.

- (a) <u>Clothing Allowance</u>. Non-uniformed officers shall receive a \$600 annual allowance for the purchase of uniforms/shoes and uniformed police officers shall receive \$400 annually, an increase from the current allowances of \$550 and \$375, respectively.
- (b) <u>Duty details</u>. Private duty details will be completely administered by a third party, with no administrative involvement from the City, though the City will be allowed to collect an administrative fee from the third party to offset the cost of vehicle usage and worker's compensation coverage. The rate of pay for details shall be at least \$30 per hour and shall not be considered City wages for any purpose.

• <u>Pension.</u>

- (a) <u>Stipend.</u> Pension plan members employed by the City as of July 1, 2020 who retire from City service after the ratification date of the CBA will receive a monthly post-retirement stipend of \$25 for each year of service up to a \$600 monthly cap. The stipend will be discontinued upon the employee reaching the age of 65.
- (b) <u>DROP Eligibility</u>. Employees who have 15 or more years of service as of July 1, 2020 may enter the DROP at any time after reaching the age of 50.
