ACTUARY'S REPORT:

Mr. Dulaney presented and explained the annual cost study. Mr. Dulaney's exhibit illustrated the offsetting effects of actuarial gains when reducing the assumed funding interest rate. No action taken at this point.

Principal – Investment Monitor Report:

Mr. Pittenger indicated that as of September 30, 2021, the portfolio had a market value of \$5,224,404.27. On a rolling one-year basis, the net rate of return was 13.4%. The annualized net rate of return since inception (February 22, 2013), was 9.36%.

NEW BUSINESS:

Staff Review - Mr. Williams advised the Board that PPA has not revised its payment since October 2018. Mr. Williams reflected that he is not seeking a raise, simply trying to keep up with the CPI. The Board was asked to consider only if they were satisfied with the services being rendered. After review and discussion of this matter, Ms. Anderson made a motion to revise the monthly PPA payment by 6% which ties to CPI through October 2021, effective December 01, 2021, seconded by Mr. Mitchell. Motion passed 4-o. Mr. Williams thanked the Board for allowing PPA the opportunity to serve the Plan.
