Bookkeeper Agreement - Mr. Williams stated that the Bookkeeper has asked for an increase. The new agreement has been sent to Fast Forward Accounting for their review and comments. Ms. Klausner-Parish will notify Fast Forward that it was mentioned at the meeting today and cannot be signed until the final copy is signed.

Mr. Klausner-Parish will check with KSDT for an update on the agreement.
